Minutes of the meeting of “State Indemnity Sub – Committee (SISC) Meghalaya, Shillong held on the 8th October, 2024 at 1:30 PM.

Members present at Annexure I

The meeting was chaired by Dr. J.S. Momin, DHS (MCH&FW), Shillong who welcomed all the members present. She then provided a brief overview of the meeting focused on the Family Planning Indemnity Scheme, covering its objectives, key features, eligibility criteria, requirements, and the process for accessing the scheme and to examine four cases of failure of sterilization. She then handed over to Dr. N. E Kharsahnoh, Addl. Director of Health Services (MCH&FW), Member Secretary of the Committee for case wise presentation.

The details of the four cases are as follows:-

As per USG conducted on 27.11.2023, revealed a bulky right ovary with a heterogeneous lesion suggestive of ectopic pregnancy.
Case-III	West Jaintia Hills	Aediamtre Tariang, Jawmusiang, Jowai	Dr. Norman Tunnel Hospital, Jowai	LSCS/ Bilateral tubectomy 5.05.2020	Bilateral Tubal ligation failure performed on 05.05.2020	An ultrasound revealed a small uterine collection and a left ovarian cyst. A laparotomy on October 1, 2023, found an inflamed appendix and signs of right ectopic pregnancy, leading to a diagnosis of right tubal abortion and appendicitis. Treatment involved salpingectomy and appendicectomy Urine β-hCG test done on the 1.10.2023 - Positive and HPE – Tissue (Rt. Tubal abortion done on the 5.10.2023, Impression: Tubal Product of conception.

An ultrasound on 1.03.2024 confirmed a single live intrauterine fetus in cephalic presentation, corresponding to 30 weeks and 3 days of gestation. Second PPS was conducted at GDH Shillong, with tubal ligation and bilateral fimbriectomy performed

The Committee found that these four claims were genuine, correct and all the documents were in position and decided for **Case-I: Failure of Bilateral tubal ligation, Case- II: Failure of Bilateral tubectomy, Case -III: Failure of Bilateral tubectomy, Case-IV: Failure of Tubectomy** an amount of Rs. 60,000/- (Sixty Thousand) each may be given to the beneficiaries.

Dr. W Shangpliang, Obs&Gynae Specialist, member of the committee suggested to empanel doctors performing sterilization in private Hospital.

It was decided that all the private hospitals and also the private practitioners practicing in the private hospitals should be accredited and empanelled for conducting sterilization procedures as per norms for bringing out uniformity with regard to sterilization procedures to increase the accessibility of beneficiaries to the sterilisation services.

The meeting ended with a vote of thanks from the chair.
