The District Family Planning Indemnity Subcommittee meeting was held in the office chamber of the Deputy Commissioner on 26/08/2021. The following members were present in the meeting:

The District MCH Officer informed That the Patient named Lt.Oksime M Marak from Sandong Songma, South Garo Hills, Meghalaya was referred from Allagre CHC to District MCH Hospital Tura on 08/12/2020 due to Pre-eclampsia and had delivered (Normal Delivery) a twin Male babies on 11/12/2020. The patient was taken into the OT for postpartum sterilization on 15/12/2020 but the patient collapsed inside the OT and later shifted to Tura Civil Hospital and expired on the same day (15/08/2021). The Committee had earlier sat on 21/04/2021 regarding her case and the papers were sent to Shillong for approval but was returned as some of the formats needed to be completed.

Therefore, this meeting was called for the conduct of Death audit following sterilization by the District Family Planning Indemnity Sub-Committee by going through the records.

Recommendations from the Members of the Committee

- All the members present agreed that the case of Lt.Oksime M Marak falls under the section 1A of the Family Planning Indemnity Scheme and is eligible for the scheme.
- ICU needed to be urgently set up at District MCH Hospital for Maternal cases.
- Proper Pre-anaesthetic check up should be done before starting the procedures.
- Medicine and obstretician specialists to attend to all the Ante-natal and post-natal cases on priority basis.



Minutes- Formation of District Family Planning Indemnity Subcommittee

The District MCH Officer started the meeting by informing the members present that a case of sterilization failure was received from Phulbari CHC on the 14th april 2021.

- The District MCH Officer also informed That the Patient named Smt.Brithila M Sangma from Rongsaigre, P.O.Phulbari , West Garo Hills, Meghalaya had undergone Minilab Tubectomy at the District MCH Hospital on 31/07/2019 and now she is found to be pregnant again with the pregnancy test done on 24/03/2021.
- The District MCH Officer also informed That the patient is eligible for the Family Planning indemnity scheme of Rs 60000 under section 1c of the scheme.
- The District MCH Officer also informed that there was also a case of maternal death named Lt.Oksime M Marak from Songdong Songma,South Garo Hills, Meghalaya at Tura MCH Hospital in the month of January 2021 during the process of sterilization and it is also eligible under the Family Planning indemnity scheme under section 1A.
- In this regard The Gynaecologist of District MCH Hospital informed the members present that the Patient was taken into the Operation Theatre for the sterilization procedure but the patient went into coma before the procedures were started and had to be referred to Tura Civil Hospital for further management.
- Hence, the The District MCH Officer informed the members present that the case is also eligible under the Family Planning Indemnity scheme.

Points from the Deputy Commissioner

- The Deputy Commissioner informed the members present to give the amount of money to the eligible patient of Phulbari CHC as per the guidelines of the Scheme.
- The Deputy Commissioner also informed to include the case of maternal death during the process of sterilization at the Tura MCH hospital during the month of January 2021.
- The Deputy Commissioner also informed to give the amount of money to the family members of the deceased mother as per the guidelines of the sheme.


