MINUTES OF THE STATE INDEMNITY SUB- COMMITTEE (SISC) MEGHALAYA, SHILLONG

HELD ON THE 21st SEPTEMBER, 2021 AT 10:00 AM

The meeting was presided by Ramkumar S, IAS Jt. Secretary Health and Family Welfare Department Cum Mission Director-NHM, Meghalaya, Shillong who welcomed to all the members. Dr. (Mrs). R. F. Tariang presented the two cases to all the members. One was a death case during process of sterilization at Tura MCH Hospital, Tura from Sandong Songma village of South Garo Hills District and one case of failure following sterilization at MCH Hospital, Tura from Rongsaire Phulbari village under West Garo Hills District. The case sheets of both the cases were discussed and relevant documents were scrutinized by the members of the sub-committee.

The details of the two cases are as follows: -

The committee found that these two claims were genuine, correct and all the documents were in position and decided for **Case-I** (*case of failure following sterilization operation*) an amount of Rs. 4 lakhs (*Four lakhs*) may be disburse to the family members of the deceased. For **Case-II** (*failure of sterilization*) an amount of Rs. 60,000/- (*Sixty thousand*) may be given to the beneficiary.
