Storage area should comply the following requirements:

- Space requirement: Approximately 2000sqft empty space, preferably with no partition
- Must have power supply and free from encumbrance
- Property should be easily accessible, easy to locate and has public transport system that is not complicated.
- The location should be safe, and the property should have security features such as a gate and adequate outdoor lightening etc.
- Exterior doors and windows that can be locked from the inside.
- The yard or compound should have a fence or wall which is kept free from overhanging branches or thick bushes.
- Should be free from risk such as fire and flood
- Preferred Location: In and around Shillong area, East Khasi hill District

1. Taxes, Duties and Levies:

- a) Quotation must clearly mention the GST no. in their offers and invoices.
- b) In case if there is a decrease in the Statutory Taxes / Duties / Levies, the same has to be passed to the Purchaser

2. Compliance of the Laws of the land:

The quotationer shall comply with all state and local laws and regulations shall obtain all necessary licensing for the operation of its business and shall further comply with all quality control standards promulgated by the authority from time to time.

3. Termination:

NHM, the Meghalaya shall have the right to immediately terminate this Agreement by giving a written notice to the Supplier in the event that Supplier does any of the following:

- I. Fail to comply with the Work order.
- II. Files a petition in bankruptcy or is adjudicated bankrupt or insolvent
- III. Breaches any provision of this Agreement, and fails to cure such breach within seven (7) days after it receives a written notice of breach from the NHM, Meghalaya.
- IV. NHM, the Meghalaya has Right to Terminate without giving any Cause. NHM, Meghalaya shall have the right to terminate this Agreement by written notice.
- V. Upon receipt of the notice of termination from NHM, the quotationer shall either immediately or upon the date specified in the notice of termination, cease all work except for such as the NHM may specify in the notice of termination. In the event of termination of the Contract the NHM shall only pay to the L1 quotationer, the Price for the parts executed by the L1 quotationer as of the date of termination.

4. Infringements:

- a) The L1 quotationer agrees to fully cooperate with NHM, Meghalaya in the prosecution of any such suit against a third party and shall execute all papers, testify on all matters, and otherwise cooperate in every way necessary and desirable for the prosecution of any such lawsuit

5. Governing Law; Dispute Resolution:

- a) This Agreement shall be governed by, and construed in accordance with, the laws of the India; without regard to conflict of law principles, and under the jurisdiction of Meghalaya and language shall be English

6. Dispute Redressal Committee:

All disputes can be addressed by amicable settlement by a committee constituted by Mission Director of NHM, Meghalaya.

7. Arbitration:

- a) In the event of any question, dispute or difference arising under this contract (except as to any matters the decision of which is specially provided for by the general or the special conditions.), the same shall be referred to the sole arbitrator or an officer appointed to be the arbitrator by the Mission Director NHM Meghalaya. It will be no objection that the arbitrator is a Government Servant or that he had to deal with the matters to which the contract relates or that in the course of his duties as a Government servant he has expressed views on all or any of the matters in dispute or difference. The 'Award' of the arbitrator shall be final and binding on the parties to this contract.
 - b) In the event of the Arbitrator dying, neglecting or refusing to act or resign or being unable to act for any reason, or his Award being set aside by the Court for any reason, it shall be lawful for the Mission Director NHM Meghalaya to appoint another arbitrator in place of the outgoing arbitrator in the manner aforesaid.
 - c) It is further a term of this contract that no person, other than the person appointed by the Mission Director NHM Meghalaya as aforesaid, should act as arbitrator and that, if for any reason that is not possible, the matter is not to be referred to Arbitration at all.
 - d) Upon every and any such reference, the assessment of the costs incidental to the reference and Award, respectively, shall be at the discretion of the arbitrator.
 - e) The venue of arbitration shall be the place from which formal Acceptance of Tender is issued or such other place as Mission Director NHM Meghalaya at his discretion may determine.
8. Payment will be made after successful execution of the order and on submission of bill, and payment is subject to availability of fund.
 9. Quotationer who quoted the lowest rate will be awarded with the contract.
 10. If L1 is more than one, the Work Order will be issued to all L1 quotationers with equal quantities or as per the capacity of the L1.
 11. Price should be quoted in per sqft inclusive of tax.
